  - i. District archived **3rd Delta Rank in Financial Inclusion and Skill Development Indicator in March 2019** & awarded additional grant of Rs 3 Crore, out of which Rs. 281.11 lakh stands utilized as on date.
  - ii. District Kupwara achieved 3<sup>rd</sup> Delta Rank under Financial Inclusion & Skill Development for the month of May 2022 & Awarded Rs. 3.00 Cr. by NITI Aayog. The plan is under implementation.
  - iii. District Kupwara achieved **good rank under Agriculture & water Resources for the month of April 2023** & Awarded Rs. 3.00 Cr. by NITI Aayog, for which project proposal have been submitted.
