The release of funds shall be subject to the following conditions:

- i) The expenditure shall be made strictly, according to the classification under which funds have been authorized by the Finance Department.
- ii) Treasury Officers shall not entertain bills without complete classification under which funds have been authorized by the Finance Department.
- iii) Drawing and Disbursing Officer (DDO) shall complete all codal formalities before presentation of bills at the Treasury.
- iv) Treasury Officer shall not allow parking or drawl of funds in the Civil Deposit without prior concurrence of the Finance Department.
- v) All Codal provisions of GFR-2017 shall be adhered to.
- vi) No work/activity shall be started without obtaining the Administrative Approval and Technical Sanction by the Competent Authority.
- vii) All the sanctions/ approvals and clearances shall be in place before drawl of money from the treasury.

- viii) FA/CAO, PD&MD shall vouchsafe the availability of funds on BEAMS portal and accordingly release the funds to the concerned.
- ix) The District Development Commissioners shall ensure that works/activities are executed after observing all codal formalities and are completed during Current Financial Year (2022-23). There should be no duplication of works/activities. Progress reports (Physical & Financial) shall be furnished to PD&MD on monthly basis and Utilization Certificate (UC) of the funds released shall be furnished by or before 31st March, 2023.
- x) The works/activities shall be subjected to Physical verification also, therefore, DDCs shall ensure that proper record and photographs (pre and post) are maintained at the District level for each activity under the scheme.
- xi) The conditions stipulated in BEAMS generated order may be adhered to in letter & spirit.
- xii) This is one time release and no spill over shall be allowed. The funds shall not be available for re-appropriation/ diversion at any level.
- xiii) The funds shall be debited as per the following account classification:
