C. Significant achievement/s:

- Action Plans for establishment of Solid Waste Management projects in all 78 ULBs of J&K UT Under implementation and approved by UT level Apex Committee on SBM-U.
- > Procurement of machinery and equipment has been initiated by the all the implementing agencies.
- ➤ Jammu Municipal Corporation (JMC) in collaboration with NAFED is setting up of 350 TPD MSW processing plant at Jammu, which is under execution. The foundation Stone of the project was laid by Hon'ble Lt. Governor on 09.07.2021.
- ➤ JMC is in a process of establishing a separate Integrated Solid Waste Management (ISWM) facility at Bandurakh on PPP mode with a capacity of 125 TPD. The Material Recovery Facility at Bandurakh was inaugurated by the Hon'ble Lt. Governor on 16.07.2021.

- ➤ JMC has started Bio-remediation work at Bhagwati Nagar and Kot-Bhalwal dump sites having 1,20,000 MT and 3,50,000 MT of waste respectively. Approx 60,000 MT waste treated till now.
- > JMC has started construction of transfer stations and tender has been floated for procurement of stationary compactors with hook loaders.
- ➤ Six Bins Tricycles Rickshaw. As per the action plan total 599 No's rickshaw were proposed and out of that 100 No's rickshaw were purchased in 1st phase.
- ➤ E-Rickshaws. As per Action plan total 60 E-rickshaws were proposed and 40 E-rickshaws has been procured.
- Auto Tippers. 89 auto tippers have been procured.
- > Transfer Station with Stationary Compactors. Construction of 8 transfer stations are under process and tender floated for procurement of stationary compactors with hook loaders.
- ➤ W2E Plant having the capability to deal 500 + 125 MTPD of waste and energy generation capacity of 5 MW is being set up at Achan Srinagar by SMC. The PPA has been submitted to JERC and project proponent has to get the rates/tariff adopted.
- Outsourcing for 100% D2D collection of waste has been initiated in two zones of SMC out of four. The DPR has been prepared.
- ➤ Bio-mining/Bio-remediation of legacy waste dumped at Achan, Srinagar Tendering process finalized.
- ➤ Tenders floated for construction of landfill Cell No. 4 at Achan. Technical &financial evaluation done and sent for accord of Administrative Approval.
- > 100 Hoopers and 35 tractors alongwith trollers have been procured.
- ➤ Directorate of Urban Local Bodies, Jammu has established Project Implementation Unit for handholding in establishing SWM projects in 36 ULBs.
- ➤ 44 mini hoopers/ vehicles have been procured and LOI for 100 vechicles placed with MED.
- > SLRM facility under progress in 19 ULBs. Tender floated for 6 SLRM faculties.
- For Bio-remediation of legacy waste, contour Survey for 6 Sites completed (Kathua, Samba, , Doda, Bhaderwah and Udhampur) have been completed.RFP is being floated.
- ➤ RFP for Dumpsite Remediation for Katra Municipal Committee for 82,000 Tonnes of legacy waste floated and LOI is being issued.
- 107 Auto Tippers Procured through State Motor Garages.
- ➤ Tender for disposal of Legacy Waste, has been floated on 10/05/2022 for 5 ULBs vizPahalgam, Ananthnag, Bijbehara, Shopian and Pampore
- More than 35000 awareness activities and D2D campaigns have been organised by ULBs for Source Segregation for which electronic/print media have also been involved

- i) Maximum GPs are without PDD power supply J&K.
- ii) A lot of garbage, cow dung etc. are stored in many GPs . Difficult approach to some dirty GP's result in poor maintenance of GPON equipment.
- iii) Poor *custodian*ship by VLWs results in theft & damages to the installed GPON equipment like solar panel, Earthing wire etc. in GPs
- iv) Buildings are damaged in some GPs increase the chance of damaged/theft of the equipment.

- vi) The ten GPs have been shifted to MC limits there by the custodian ship of said GPS have been withdrawn. The same needs an immediate attention by respective Municipal cooperation to avoid any loss / damage to the equipment.
- vii) In our daily routine visit during raining season at present so many GP buildings have leakage of rainy water inside the equipment rooms which has already damaged the equipment at several places. This needs immediate attention on war footing to repair the buildings. Needless to mention one GP building of kanhal of Bishnah Block is at the verge of collapse which may not only risk the lives of maintenance staff but also damage the whole installed equipment.

- viii) Concerned BDOs as nodal officer be intimated to get the maintenance GPs done regularly as the Bharat net commercial expanding all around the service ready GPs as per the standing instructions in this regard.
- ix) It has been observed the sarpanches/BDOs at some GPs are not allowing the provision of commercial FTTH connections on the pretext of official letter from BDOs /secretary RDD. The BDOs/ Sarpanches must be educated regarding Bharat net projects through their respective sections to avoid delay in commercial FTTH activity.
